- (vi) to publish books newspapers, periodicals and other literature for the development of education, knowledge and wisdom among the public.
- (vii) to open libraries, reading rooms and to conduct evening classes and correspondence courses.
- (viii) to establish maintain run, develop, improve extend and support and to grant donations for and to aid in the establishment, maintenance, running development improvement and extension of schools, colleges vocational institutions, sports complexes, hostels creches, libraries reading rooms, recreation centres holiday camps, research institution and other facilities calculated to be of use in imparting education and development of knowledge to the general public or to the student population in particular.

- (xi) to amalgamate or affiliate any other institution whose objects and interests not in any manner directly identifies with and or advancement of the objects or interest of the T.N.T.A.
- (xii) to establish, run, maintain, develop, improve extend and support medical schools, colleges, hostels research institutions in furtherance of research in medicine such as allopathy, homeopathy, naturopathy, unani, ayurvedic and such other system or systems.
- (xiii) to establish run, maintain, develop, improve extend, manage and support hospitals, dispensarium laboratories, convalescent home, post treatment care centres of all types and natures and other allied institutions for treatment of persons suffering from illness or mental infirmities of for the reception and treatment of persons during convalescence or of persons requiring medical attention or rehabilitation.

- (xv) To award grants, scholarships, fellowships and financial assistance or encouragement to the doctors, students, research fellow in furtherance of research in medical sciences.
- (xvi) To give all necessary assistance for the disabled persons, deaf, dumb mute etc by way of financial assistance or any other assistance in kind by purchasing and supplying them necessary equipments etc or any other type of assistance required by them.
- (xvii) To help the poor and needy or incapacitated persons in poor and deplorable circumstances.
- (xviii) To construct and maintain bazaar for the aged.
- (xix) To aid and assist artisans or traditional craftsmen by undertaking construction of temples and monuments of archaeological or artistic importance, to repair and maintain removable, or repair any temple or structure of archaeological importance by way of assisting local artisans, craftsmen etc.
- (xx) To give doles to the poor and needy, to provide food, clothing, shelter etc in time of distress like famine floods drought etc.
- (xxi) To undertake to construct maintain repair, community centres, community tanks and other public utility infrastructure to provide for employment etc to the poor and needy.

- (i) To receive by donation or gift, purchase, lease exchange or otherwise, lands, buildings or structures of any tenure or description and to build, construct or lands and extend improve and repair buildings and structures and otherwise deal with the properties for the purpose aforesaid or any of them.
 - (ii) To receive gifts, donations and contributions whether in cash or kind.
 - (iii) To carry on such other objects incidental or ancillary to the above said objects.
- If the trustees of the opinion to promote any object which is not specified hereinabove they are at liberty to do the same and all the receipts that may be obtained by the trust should be placed only for the promotion of the objects of the trust which has been mentioned hereinabove.

PROVISIONS:

- If it is specifically provided that:
- (a) The above objects shall be independent of any other and the trustees constituted may, from time to time apply the income, profit and funds of the TRUST for carrying out the objects of the TRUST.
 - (b) The objects of the TRUST shall not be restricted on the basis of caste creed or community or religion or race.
 - (c) The objects and the activities of the TRUST shall be limited to 25%.
 - (d) The objects of the TRUST shall not be carried on profit motive so long as the prohibition under provisions of the income tax act are in force.

7. APPOINTMENT OF TRUSTEES: The first trustees of the trust has been appointed in this deed of trust and their period shall continue for five years. The existing trustees shall be in other case called as board of trustees can elect a person who shall be called as chairman of the trust and his period also shall not exceed more than five years.

E. MINIMUM NUMBER OF TRUSTEES: the board of trustees shall consist of atleast 5 and at any cost not more than 15. As and when vacancy arises by death or retirement or removal or because of any reason, the post can be filled up by the board of trustees immediately by convening a meeting either by resolution or by circulation of resolution.

F. MANAGING TRUSTEE/CHAIRMAN: SRI.V.Chandrasekaran will be the managing trustee and shall also act as Chairman of the Board of Trustees and shall preside over the meetings of the board and shall have a casting vote in cases of equal division in voting while passing resolutions.

G. TERM OF OFFICE: the term of board of trustees so appointed shall be five years. The constitution of the board of trustees and its term of office etc. after the above period of five years shall be determined by the board of trustees. A trustee also may resign his office by giving one month notice in advance and if any vacancy arises because of such event it can be filled by other trustees in the form and method as stated hereinabove.

H. Powers of the Board of Trustees: the board of trustee shall set, maintain, and administer the trust.

I. Powers of the Board of Trustees: without prejudice to the generality of the powers vested in the TRUSTEE and subject to the provisions of the income tax act 1961, the TRUSTEE shall have the following specific power:

- a) To manage all the affairs of the TRUST
- b) To publish books on any subjects acquire copy right or other intangible benefits.
- c) To acquire by purchases, gift, grant, exchange, lease, hire or otherwise properties of all kinds including movable and or immovable properties to improve and to add to the corpus of the TRUST and hold the same for the purpose of the TRUST and hold the same for the purpose conditions and covenants contained herein.
- d) To sell mortgage lease out or give on licence or otherwise alienate all or any of the properties of the TRUST at such time for such consideration on such terms as the TRUSTEE may deem fit.
- e) To invest the TRUST funds in such manner as the TRUSTEE feel in their absolute discretion and it is hereby expressly provided

2. To vend, recall or vary all or any of the investments from time to time.
3. To enter into agreements, contracts and cancel or vary them.
4. To receive any money and to grant receipts in discharge thereof.
5. To institute, prosecute defend and compromise all actions and proceedings before the Government Court, tribunals, authorities including courts, appeals review petitions, conventions and the like and to represent the TRUST before them.
6. To enter into any compromise and to refer the matter to arbitration.
7. To engage the service of any person or persons upon such remuneration and terms as the TRUSTEE may deem fit and take disciplinary action against them and also terminate their services.
8. To incur all costs and expenses considered by the TRUSTEE to be necessary for the due and efficient management of the affairs and properties of the TRUST.
9. To open bank account or accounts for the purpose of deposit of funds in the name of the TRUST.
10. To borrow from bank for the purpose of investments in the TRUST and also from 1st parties, if they have their own funds on such rate of interest as the TRUSTEE may deem reasonable.
11. To delegate to any person or persons all or any of the foregoing powers conferred on the TRUSTEE subject however to their retaining the ultimate control and direction over the delegatee's action and conduct.
12. To incur all expenses for the objects of the public beneficiaries in India.
13. To transfer any funds or property of the TRUST to any other TRUST of which the objects herein are also same.
